In continuation to this Ministry's letter even number dated 22.08.2016, you are informed that the proforma for preparation of LB has been made available on MGNREGA MIS. A copy of the proforma is enclosed for reference.


2. It is once again reiterated that while uploading data in NREGA soft, it should be ensured that all columns and rows are duly filled in, especially, month wise projection of labour demand during FY 2017-18. It also needs to be ensured that units [volume/length/area etc. in respect of works & numbers in cases of person days, costs etc.] are filled in correctly. LB is an important tool for the Ministry to assess adequate and advance budget requirements for the MGNREGA and smooth and timely release of central share of funds to your State. GP- wise online entry should be completed for all the districts of your State.

3. In case, States experience any problem in uploading of data in MIS, the same may be shared with this Ministry immediately for remedial action.

4. You are requested to submit online LB for FY 2017-18 for each district of your State in the enclosed profoma **latest by 31.12.2016.**

This may be treated as **MOST URGENT**.
