- 3. Asset Geotagging
- 4. Moderation of the pending geotagged assets
- 5. Accuracy of the geotags

All States/UTs should ensure that Ministry receives the response of letter dated No. M-11011/02/2016-RE-III/VII dated 20th March 2017 at team@geomgnrega.in before 6th May 2017.
