**Subject: Regarding status of accounts registered on PFMS for all implementing agencies in the State/UTs for MGNREGS**

Sir/Madam,

Please refer to the Ministry even letters dated 28<sup>th</sup> July, 10<sup>th</sup> August & 13<sup>th</sup> October 2017 regarding the registration/de-registration of accounts on PFMS. The States/UTs were required to share details of mapping of accounts under MGNREGS that were still un-mapped on PFMS. Along with this, all unused accounts under MGNREGS were required to be unmapped from PFMS.


In this regard, the States/UTs have shared the data with the Ministry for mapping and un-mapping of the accounts on PFMS under MGNREGS. The details of the final status post mapping/un-mapping of accounts on PFMS is annexed in **Annexure No 1**.

The State/UTs are requested to kindly analyze & confirm the final status of the accounts on PFMS and inform the Ministry if, any further mapping, un-mapping and activation of accounts earlier marked as Not in use on PFMS is required. The details of the accounts registered on PFMS has already been shared with the nodal officer of the State/UT.

After completion of the above exercise the Ministry will freeze the status of accounts on PFMS. The State/UTs are requested to justify the number of accounts kept at each level and the purpose of these accounts to the Ministry.

## Requisites for Mapping and Un-mapping of accounts on PFMS

### Mapping of accounts

- The request for mapping of accounts at State level needs to be sent along with following documents: -
- Letter from the State mentioning the details of the account and purpose/usage of the account.
  - Screen shot of the accounts registered on PFMS specifying the details of the Unique Agency Code.
  - Cancelled cheque /Pass book copy or Bank letter mentioning the details of the accounts to be approved on PFMS.

### Un-mapping of accounts

- The un-mapping request should be sent along with formal request letter and details of accounts (in excel format) should be emailed at the below mentioned email id of Ministry: -
