In the recent past, the Ministry has taken steps to simplify the implementation of the programme through various good governance initiatives viz.


- i. Job Card design, verification and updation
- ii. Maintenance of Case Records /Work Files
- iii. Maintenance and updation of 7 Registers
- iv. Design & durability of Citizen Information Boards

These initiatives aim to increase the effectiveness of the programme implementation at the field level. The Ministry has issued suggestive frameworks for these initiatives after due consultations and incorporation of good practices by the States.

The Ministry has conducted field visits to various States to study the status of implementation of these initiatives. It was observed that there is a need for capacity building of field functionaries for smooth implementation of Good Governance Initiatives at gram panchayat level. It is proposed to conduct two days national level workshop titled "**Good Governance in Administration of MGNREGS- Dissemination of Indicative Framework and sharing of Best Practices**" on 28th - 29th November, 2017 at SCOPE Complex, Lodhi Road, New Delhi. The workshop is aimed to **create a pool of 'Good Governance Resource Persons (GGRPs)**' in each States/UT, who will further train the field functionaries in their respective State/UT. **These GGRPs should not be changed/ substituted after being capacitated by the Ministry during this workshop.**

You are requested to identify and nominate GGRPs, who may be drawn from officials involved in administration /implementation of MGNREGS at State /District level for attending the workshop as listed in Annexure **latest by 20th November, 2017** on ak.sumbly@nic.in with a copy to anilkatta2311@gmail.com and shrutisinghjain@gmail.com. The programme schedule will follow shortly.
